




ToIP Glossary progressing as a ToIP Specification

- https://trustoverip.github.io/ctwg-main-glossary/
- Includes almost 400 terms that we want to harmonize across all ToIP deliverables
- It does not preclude any WG from defining additional specialized terms for a deliverable-specific glossary
- We are still working out bugs and standardizing persistent links
- But you can begin linking to terms today!
- We expect to publish a ToIP Glossary V1.0 in July

New Version of Spec-Up: Spec-Up-T (for ToIP)

- Spec-Up is a Decentralized Identity Foundation (DIF) open source project: https://identity.foundation/spec-up/
- It includes a basic glossary feature for defining terms and referencing (linking) them within a Spec-Up document
- Brian Richter added support for external references ("xrefs")
- Now, Henk van Cann and Kor Dwarshuis have created a new extended version of Spec-Up that supports living glossaries
 - a. Edit individual glossary entries w/full GitHub history
 - b. View the version history of any glossary entry

Two New Asynchronous Task Forces

- Service Discovery Task Force (Andor Kesselman)
 - a. Standardized discovery of a functional profile of any online service
 - b. Can apply to any ToIP protocol or service endpoint

- Specification Template Task Force (Kevin Griffin)
 - a. Standardizing the Spec-Up template for all ToIP specifications

Technology Architecture Task Force

- Nearing completion of second public review draft of <u>ToIP Technology Architecture Specification V1.0</u>
 - a. First Public Review Draft published Nov 2022
 - b. Working asynchronously only meeting as needed
- Most major tasks are completed (canonical use cases, 3rd gen ToIP stack diagram)
- The final major task is full integration with the ToIP Glossary V1.0:
 the first ToIP specification to have full integrated glossary support

ACDC Task Force

- The 3 major specifications KERI, CESR, and ACDC now have IETF RFC 2119 normative keywords
- The Task Force is requesting review of this new normative language
- Please post any feedback as GitHub issues

Al and Metaverse Task Force

- The AI and Metaverse Task Force (AIMTF) has launched the Authentic Generative AI initiative to study and produce a specification of sharing authentic data between authenticated endpoints. This work intends to utilize TSP to distribute data & content in C2PA and other data formats.
- The TF is calling for use cases. To participate, please read the background and contribute your use cases in this <u>PROPOSAL</u> doc. The TF plans to publish the first blog post by July.
- Please join the meeting series at 9AM PT (bi-weekly).

Trust Registry Task Force 2.0

- Meeting every Thursday (NA/EU & APAC)
- Deliverables under way:
 - Trust Registry Protocol Specification ← under Implementers
 Review
 - Renamed to "Trust Registry Query Protocol Specification"
 - Trust Registry Query Protocol Companion Guide ← WILL FOLLOW THE SPEC

Trust Spanning Protocol Task Force

- Meets every other Wednesday (both NA/EU and APAC)
- Delivering the ToIP Trust Spanning Protocol Specification
 - Keystone of the entire ToIP stack
 - See the 18 requirements in the <u>ToIP Technology Architecture Spec V1.0</u>
- First Implementer's Draft released in April
- OpenWallet Foundation implementation project announced in May

Credential Exchange Protocols Task Force

- Held a 2-hour working session on May 30th and started working on documenting credential presentation protocols against the evaluation criteria.
- We continue to hold bi-weekly meetings where we discuss the intricacies of the various protocols and their dependencies on other technical facets.

DID Method webs Task Force

- Meets Fridays at 15:00 UTC
- Rationale for this TF: The founders saw an opportunity to secure the relatively insecure did:web method by "tunneling" a self-certifying identifier (autonomic identifier or AID) inside a did:web URL
- The spec was drafted in GitHub using the SpecUp tool
- The V1.O spec public review period ran December 2023—Jan 2024
 - Currently making revisions based on public review feedback
 - Targeting V1.0 release in Q2 2024

X.509 VID Task Force

- Meets every other Thursday at 8:30AM PT / 15:30 UTC (but on hiatus during the June conference season)
- Original goal: specify a deterministic way to use a standard X.509 digital certificate as a Verifiable Identifier (VID)
- MAJOR PIVOT: The TF concluded this goal was unrealistic—
 a better approach is to specify a standard way to add a DID to an
 X.509 certificate using the Subject Alternative Name field
- This way the cert binds the DID, the public key, and the subject
- Seeking a new co-chair to join Drummond Reed to lead this TF

NEW: Trust DID Web (did:tdw) Task Force

- New TF to write the specification for the Trust DID Web method
- TDW uses self-certifying identifiers (SCIDs) the same principle followed in KERI and did:webs
- TDW uses a JSON file structure to maintain the state transitions between different DID documents
- Strong interest at recent conferences (IIW, DICE)
- Chairs are Stephen Curran and John Jordan
- No meeting schedule set yet should start up in July

Governance Stack Working Group



Governance Stack Working Group

Focus on 2024:

- Third Generation Diagrams
- Role Requirements (Trust Registry, Verifier, Holder, etc.)

Three active Task Forces

- Governance Architecture TF Model for the Governance side of the ToIP Stack
- Attraction Pass TF wrapped up. (Static) Risk Assessment shifted to C2PA
- Issuer Requirements TF Completed (deliverables published).
 Verifier Requirements TF possible related project

Governance Architecture TF

- The start of this reporting period saw a cleanup of the 3rd generation diagram folder and contents and some additional "tweaks" to some of the diagram elements (the infinite arrows "8" for governance is now a single image rather than a collection of objects that can end up looking like spaghetti when moved...)
- Later in the period the new build explainer for the "Trust Canvas" was given several public airings at conferences and seems to be travelling well.
- In addition the group has been exploring the application of the Risk Assessment Guide and template to a real-world example - the C2PA specification. This has generated a number of learnings for the ToIP governance risk assessment tools as well as some interesting observations to share with the C2PA team.
- Future work includes the co-development with others in ToIP of a Guide for the 3rd Gen trust model.








EFWG Deliverables
