

## Year In Review - Approval



## DID Spec Public Show of Support when approved by W3C

- Mozilla publicly posted a formal objection to W3C approving the W3C
  Decentralized Identifiers (DIDs) 1.0 specification
- > SWAT team from ToIP and DIF created a document in support of the spec to be shared in a private meeting with the W3C directors.
- DIF and ToIP plan to collaborate to issue a joint communication in Support of the importance of the DID specification when approved by the W3C
- We need a team that creates the communication plan and draft the necessary documents:
