Unlike proprietary scripted Google Docs, Microsoft Word or, WordPress, Rosie is like having a robot assemble your documents authored from other documents scattered across the web. One update can automatically trigger many.

Rosie: Continuous Documentation built with GitHub, with no GitHub skills required. It's like consumer packaging for your deliverables.
