I see some grammatical issues with the document; e.g., "Defining Digital Trust Ecosystem". This should be "Defining Digital a Trust Ecosystem" or, my preference, "Defining Digital Trust Ecosystems". It is pervasive and there are other examples of using singular and plural, rather ad-hoc:

- Ecosystem in biology
- Psychologists and "Social Ecosystems"
- Ecosystem in business strategy
- Data ecosystems

Moving to section "6. Trust Ecosystems" – should this not be "6. Digital Trust Ecosystems" – the subject of this white paper?

We then see "From designing ToIP principles to defining Digital Trust Ecosystem". Again, should this not be "From designing ToIP principles to defining Digital Trust Ecosystems" as there is not one penultimate Digital Trust Ecosystem?

The mechanical issue with the document is that "Title of Document" appears on every page.
