#### Update on OIX/MOU

#### History:

- June 2021 we were referencing OIX guides in the GHP Interoperability Blueprint and is was suggested that we might want to formalize our relationship with OIX.
- OIX was open to the idea and Judith contacted LF/JDF for support. LF/JDF provided us with an approved template for MOUs
- Judith suggested that in the Exhibit portion of the MOU there be a provision for ToIP member to be able to attend OIX working groups for free so that ToIP would have the ability to attend without fees.
- Oct. 2021 a version of the MOU was approved by OIX, and presented to ToIP SC in Nov. for approval.
  SC members requested changes. Changes were made and revised MOU approved by ToIP SC Jan 2022.
- Changed MOU sent to OIX for approval, their lawyers have now requested further changes, as seen in Exhibit B sent with agenda.
- Judith spoke with Seth and then asked Nick to provide the documents referenced in the newest version of the MOU. Nick provided, see Exhibit C and D. Nick was hopeful that he could get his legal to simplify the requested changes, but was unsuccessful due to the mention of Delaware as jurisdiction.
- Judith has checked in with Seth about next steps with LF, if we choose to proceed.
