Advisory Groups

- New role within the organisation structure
- Advisory Groups set Working Group or Task Force objectives and recommend deliverables for approval
- Proposed that Advisory Groups meet on a quarterly basis
- Allows greater engagement from member organisations without significant investment of resources across the Working Groups
- Enables Steering Committee members to have more specialist guidance in the approval of deliverables
- Gives greater direction from the Steering Committee to the Working Groups to ensure they are aligned to and supportive of the ToIP Mission
- Provides additional benefits for paid members of ToIP

Steering Committee Structure

- The capacity of membership of the Steering Committee should be set at 35 organizations
- With a target model of:
 - 24 Large/Medium
 - 10 Small
 - 1 General Member Representative.
- Unless and until the overall capacity is reached, all Steering level members are inducted to the Steering Committee and have voting rights.

- The 2022-23 fees applies to new members joining from 1st July 2022.
- Proposed fees for 2024 are subject to 2023 Steering Committee approval and can only be justified if we can prove the value to the Steering Committee members.
- It is also not clear that we can justify a \$50k fee for small to medium sized companies, which is why we are proposing a change in the classification of company size in line with The Linux Foundation.

Linux Foundation

Steering and General Members are required to hold Silver Membership of The Linux Foundation with membership benefits that include:

- Provision of a legal structure for projects to be created under a neutral governance model.
- Foundational legal work to improve the quality (licensing, export controls, trademark programs, privacy programs, etc.) of our projects
- Support for essential IP protection for open source, including our support for the Unified Patents open source zone
- Provision for projects to operate as a global organization with operations spanning the United States, European Union, United Kingdom, Switzerland, China, Australia, and Japan.
