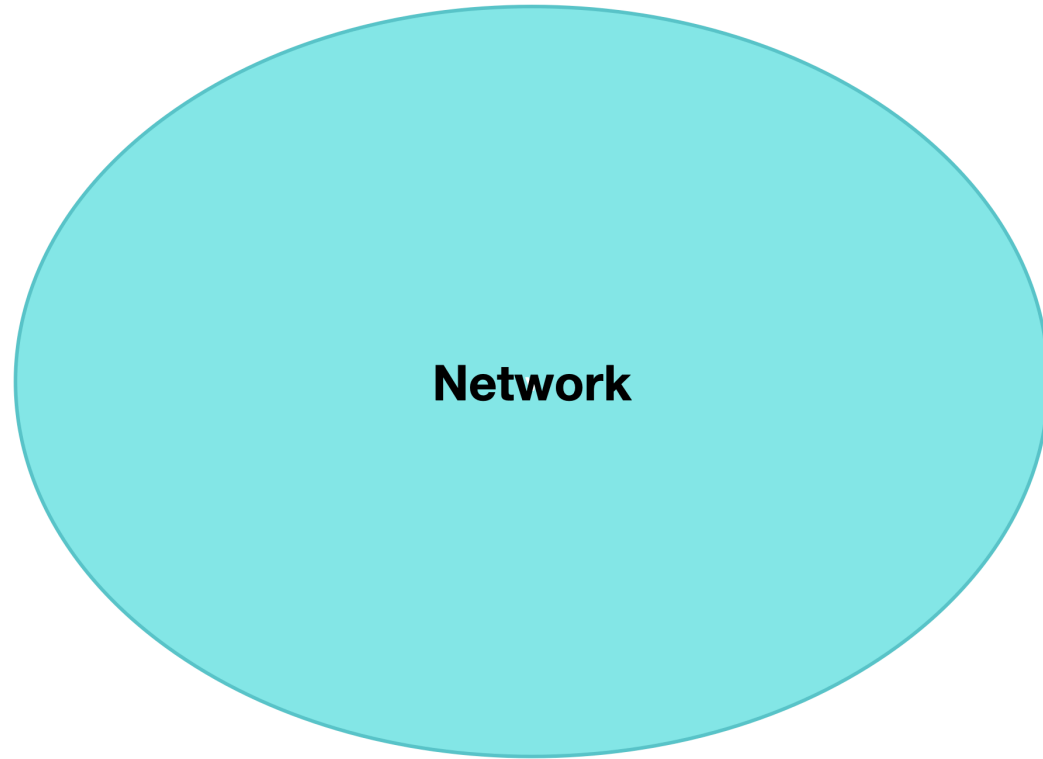

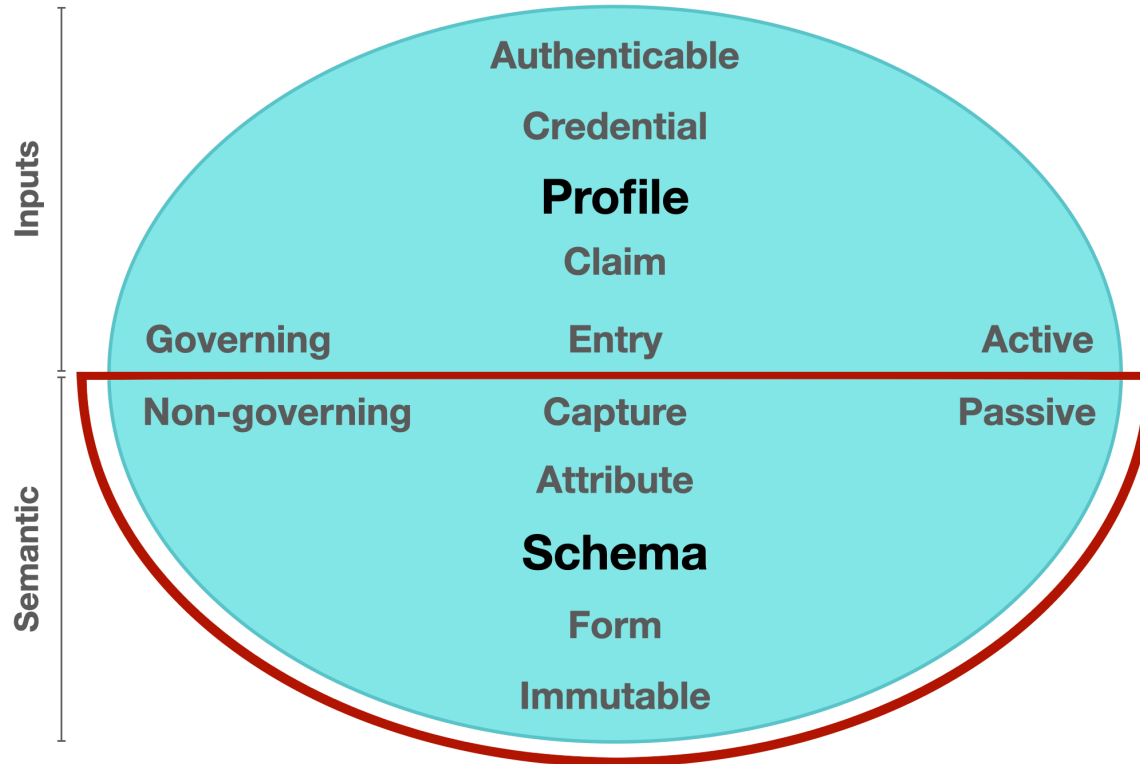

- Semantic Domain

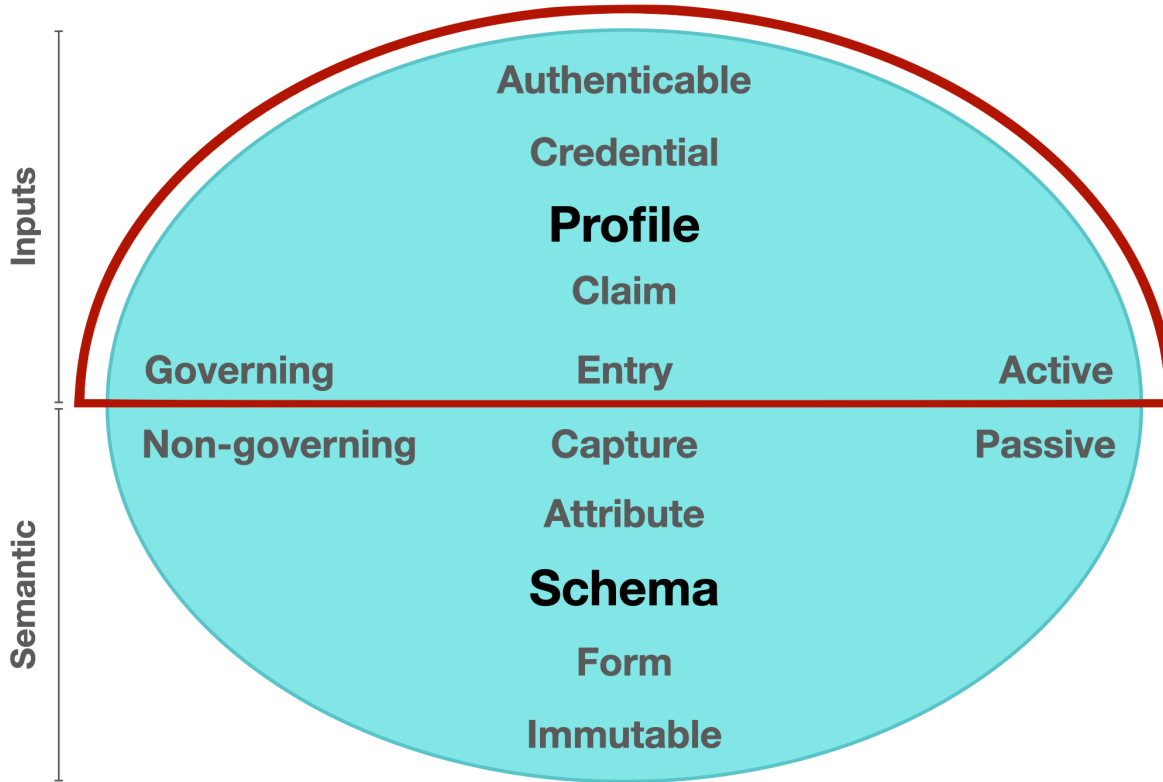

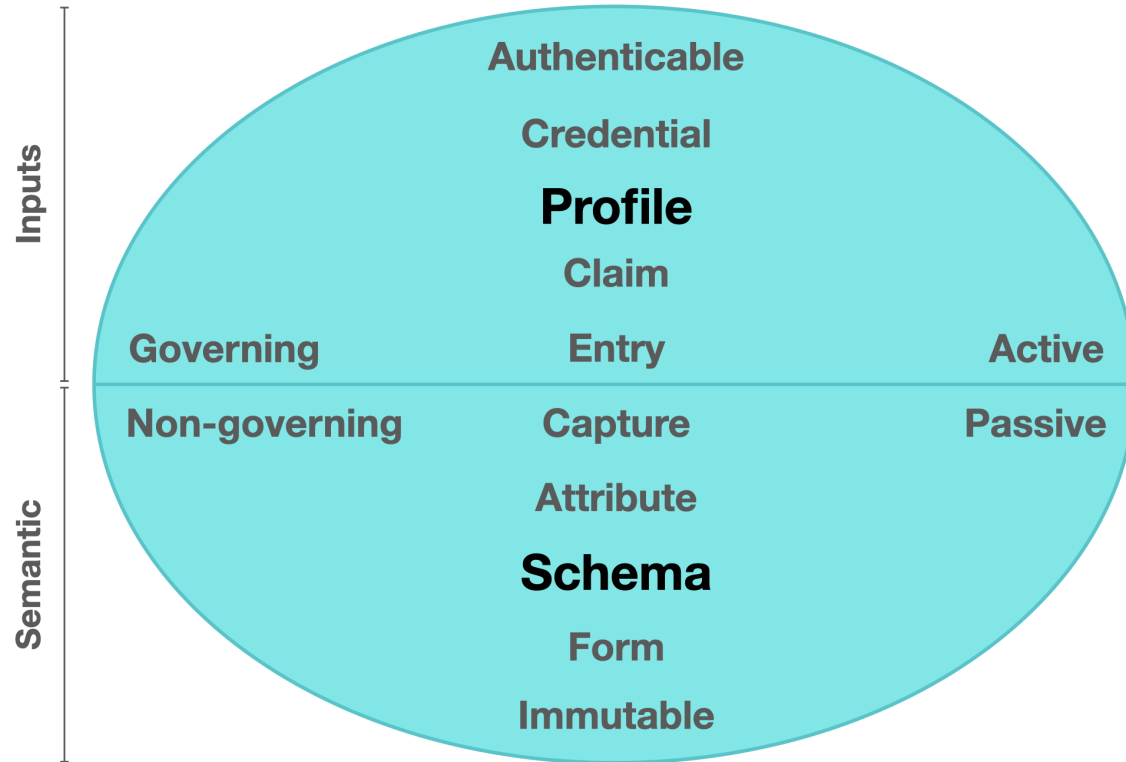
- Inputs Domain

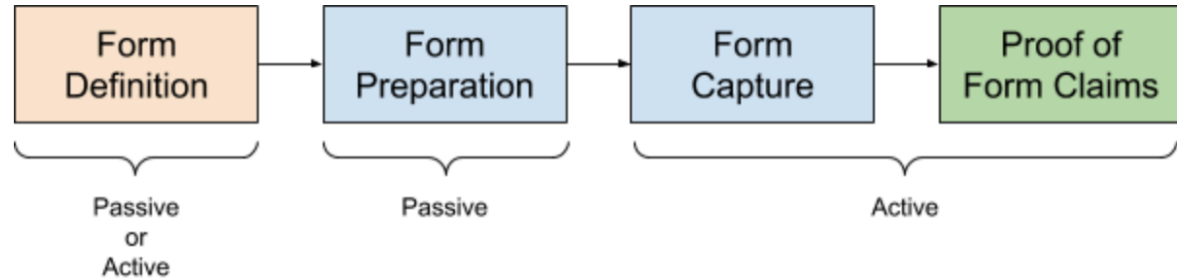

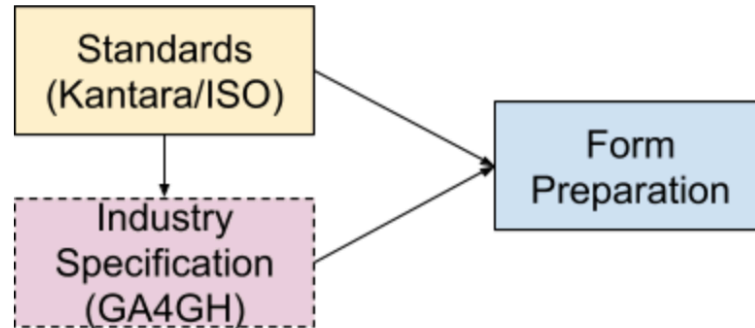

## Form Definition



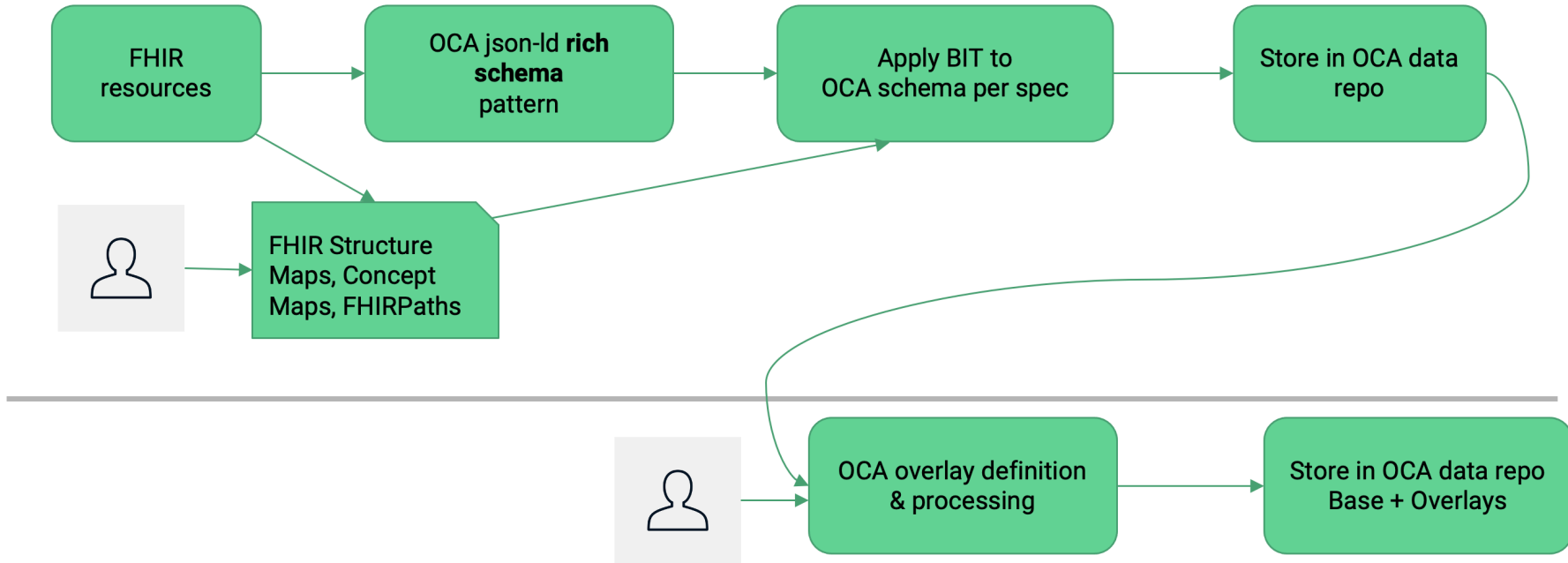
