Webinar - ToIP and Government

- Panel of ToIP thought-leaders with direct experience in working with governments
 - Dec 15 two sessions to accommodate US/EU and APAC time zones
 - US/EU session peaked at 120 attendees, while APAC session reached 20 attendees
 - Key sectors/activities covered: travel, healthcare, education, regulatory compliance, government ID, citizen services, digital transformation
 - Active participation from attendees with questions submitted to all panelists

 - Communications Committee to move ahead with Editorial Calendar that includes regular webinar events



Principles of SSI

- 12 Principles developed under the stewardship of Sovrin but not "owned" by any one organization
 - Good-faith consensus of the global SSI community
- Sovrin has reached out to ToIP and other digital trust infrastructure organizations to gather a signal of broad support
 - Steering Committee (Dec 9) recommended the Governance Stack WG form a Task Force for delivering the Principles of SSI as a Design Principles deliverable

Recent announcements - important market trends that create opportunities for ToIP

- IATA has announced that **Travel Pass program** will begin pilot by end of 2020
 - Global, standardized solution to validate and authenticate all country regulations regarding
 COVID-19 passenger travel requirements

- <u>WHO</u> is defining specifications (interoperability, governance, and design) for digital vaccination certificates starting in Jan 2021
 - "Every certificate should be recognized and verifiable by any trusted authority"
