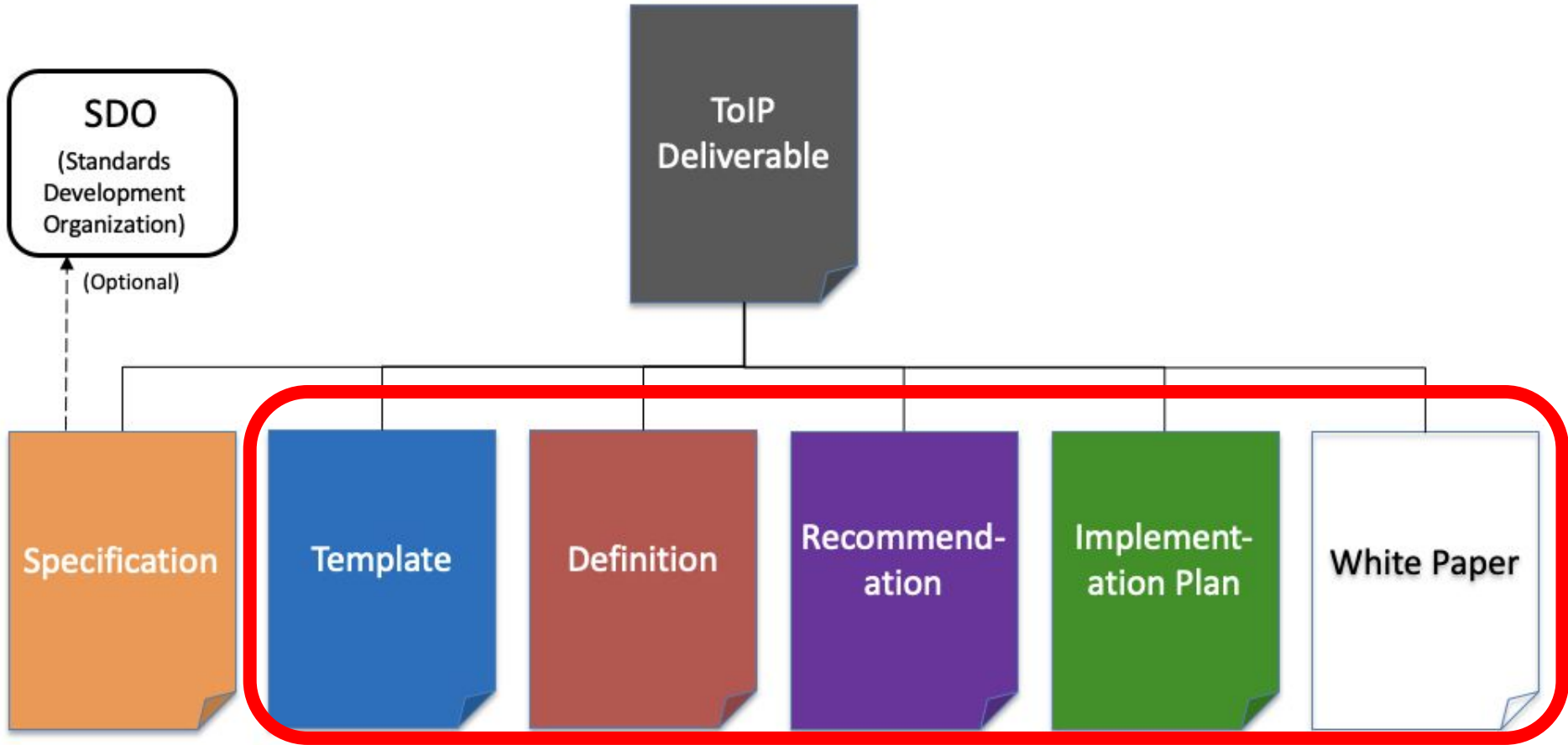
SEGF Task Force Introduction

Sovrin Ecosystem Governance Task Force (the “SEGF TF”)

- The SEGF Task Force will develop a Sovrin Layer 4 ecosystem governance framework.
- This Task Force is a sister effort to the [Sovrin Utility Governance Framework \(SUGF\) Task Force](#), a Layer 1 public utility governance framework to support the Sovrin Ecosystem and all other digital trust ecosystems.

SEGF Purpose Statement

- The Sovrin Ecosystem enables Self Sovereign Identity (SSI) as a universal service for all.
 - The Sovrin Ecosystem Governance Framework (SEGF) defines the principles, policies, and accountabilities that govern the Sovrin Ecosystem.
 - The Sovrin Trust mark is a means of asserting an organization’s compliance with the SEGF.
- As a social enterprise, independent business entity, and global SSI leader, the Sovrin Foundation is excited to utilize the ToIP platform to coordinate our community efforts for creating the SEGF V1 and SUGF V1 GFs. We also look forward to cooperation for future activities between Sovrin and ToIP.
