Remarks - John Jordan (Executive Director)

- › Trust over IP is having a good start to 2021.
- › We are setting a roadmap for Q1 deliverables and establishing an editorial calendar for communications.
- › The Foundation was asked, and has agreed, to bring leadership and expertise to the Good Health Pass Collaborative.
- › Gov't of Ontario shared its report, informed partly by our input, that shows they have the right intentions and understand their foundational role.
- › We need to better understand how to bring all members into this work, so they can benefit from our shared progress.

Good Health Pass Ecosystem Task Force Launch

- › Good Health Pass Collaborative (launched on Feb 9) - digital trust ecosystem using verifiable credentials to create COVID test/vaccination records for travellers

 - › Focus on requirements of travel industry but success can open the door to interoperable tools across many sectors
- › Good Health Pass Task Force (under EFWG) - develop the governance framework for this “ecosystem of ecosystems”
 - › Kick-off meeting - Tue Feb 23 at 1pm PT / 9pm UTC
 - › Announcement / press release planned for week of March 1

On 5 May 2020, the Linux Foundation announced a new addition to its roster of global open source ecosystem projects: the **Trust over IP Foundation**. The mission of this new Foundation is to simplify and standardize how trust is established online so that everyone can feel safe, secure, and private in all of our digital interactions—whether between individuals, businesses, governments, or any “thing” on the Internet of Things.

- › v2 - reflect progress on priority deliverables:
 - › Governance and Technology Stack TSS
 - › Design Principles: Laws of Identity, Privacy by Design, Decentralization, SSI Principles
 - › Interoperability Spec - Layer 1-3
 - › Utility Evaluation Framework

Open Discussion - barriers and solutions

- › Trust over IP aims to be an open and accessible community
- › Members are welcome at all meetings, and encouraged to contribute to work on our shared Deliverables
- › Currently, there are barriers to full member participation, including:
