Good Health Pass - Announcement

- Good Health Pass Taskforce successful/well-attended kick off (Feb 23)
 - Aim (per Drafting Groups workplan) publish Trust Framework by May 30
- > Intent is to announce Trust over IP role with a press release
 - Joint Good Health Pass/Trust over IP/ID2020 announcement
 - Steering Committee has approved \$1k expense for media wire fee
- Draft press release circulated for committee review

RESOLVED: That the Good Health Pass press release v3 is hereby approved for public release as part of a joint Good Health Pass/Trust over IP/ID2O2O announcement.
