# Project Charter (JDF 5.0)

- Revised Project Charter (JDF 5.0) came into effect April 9, 2021
  - Approved by Steering Committee (Mar 10)
- No action or change required for members previous charter carries forward into revised version
- Membership levels: Steering, General (prev. Associate), Contributor
  - No change to fee structure
- Appeal process Steering Committee decisions can be appealed in writing
- Code of Conduct welcoming and safe environment for diverse individuals

# Project Charter (JDF 5.0)


- No changes to terms related to Contributions, Antitrust, IP, Licensing for working groups and deliverables
- Members will benefit from simpler administrative steps:
  - "Join" WGs by making a contribution ... "member list" to be introduced
  - New WGs must have a scope and charters but no longer need to be signed
- Update to membership links on website in process



# Good Health Pass - Update

- Work has been advancing 9 Good Health Pass drafting groups
  - https://wiki.trustoverip.org/x/PiAB
  - "Narrative" group also developing over-arching Key Messages
- Recommendation and frameworks at varying stages of development/maturity
- Approaching community (end of April) and public (end of May) review phases
  - Method/tools being confirmed
- Outcomes will be ToIP deliverables, published under IP/licensing terms of working group
- > Excellent time to get involved read, comment, ask questions





# Internet Identity Workshop (IIW)

- Spring session (Apr 20-22) strong ToIP and Good Health Pass presence
- Multiple sessions led by members (e.g. GHP Trust Framework Architecture, Sovrin/ToIP Letter of Agreement)
- Important progress on cross-cutting issues (e.g. elements of data exchange protocols)
- Open Questions:
  - What were your takeaways from IIW?
  - How can ToIP integrate these ideas and continue building bridges to the broader VC / SSI community?



# Letter of Agreement - Sovrin/ToIP

- Aim resolve market confusion and create a framework for collaboration
  - Mutual support for separate but interrelated mandates
  - Assign member to act as liaison
  - Proactively seek opportunities to collaborate (e.g. topics of interest like IoT, communications)
- Approved and signed by both organizations
- Next steps:
  - Announcement blog post, social media
  - Liaison role designate ToIP member



# Transition - Program Manager

- Current Program Manager (D Luchuk) final day: May 19
- Linux Foundation engaged in transition to a replacement
  - Candidate identified will be confirmed soon
- Review of requirements and role service level
  - Approval/sign-off to be sought from Steering Committee
- Key issues/priorities:
  - > Finalizing/publishing deliverables incl. use of GitHub
  - Easier self-subscription to ToIP calendar
  - Providing WG leads with tools to schedule meetings, access recordings
