Transition - effective date and replacement

- Current Program Manager (D Luchuk) since Aug 2020
 - Notified (April 2021) that Public Health Agency of Canada was ending its agreement with Linux Foundation
 - Final active day at Trust over IP May 19, 2021
- Introduction Seth Newberry, Executive Director JDF
 - Linux Foundation and JDF working to identify replacement PM
 - Will work directly with D Luchuk prior to departure
 - Get started and assess channels, tools and requirements



Budget (2021) summary

- > Trust over IP budget is stable and viable
 - projected based on pro-rated membership fees for 2021
- Operating budget of approx. \$145k for the remainder of 2021
 - > Includes full payment of Program Manager expense \$125k
 - Carry-over from 2020: \$156k
- Does not factor potential new Steering members or CTWG Term Tool +/- \$20k

Areas of Focus - defining service

- Steering Committee will be presented with a service agreement
 - Define the activities / responsibilities of new PM
- Assessment of operations and requirements will carry through arrival of PM
 - Deliverables what products must ToIP publish in the next 3-6-12 months?
 - GitHub how to support members in using process that has been set up?
 - Calendar and Zoom accounts
