PII Classification and how it should be treated in DLT

#### Off-ledger

- **)** Consent mgmt.
- Provenance data (know when data is used)
- Metadata about the actual data that follows it when shared
- Data minimization (rules engine)
- Data transformation (during data sharing, not only blinding but also applying techniques like generalization)
- Access control

#### Governance

- Assessment (privacy, security, legal)
- Trust Registry
