Interoperability WG for GHP - Final Deliverable

- The Interoperability WG for GHP has approved the Blueprint as a WG Approved Deliverable.
- The Working Group Chairs had sent this deliverable to the SC for review via a draft sent on June 11th and as a final product on June 24th, 2021.
- On July 16th a revised final draft was sent out correcting the copyright attribution and one minor revision as requested by a SC member on page 13 section 4.

- SITA signed ToIP Member agreement on Friday July 23rd, 2021
- SITA indicated that there were no Essential Claims in an email received Saturday July 24th 2021
- Question: Do we want to push for a formal Withdrawal of Notice of Patent Exclusions which is DocuSigned, or take the email as notification?

- After approval by SC the date on the final version will be changed from June 30th 2021 to August 1st 2021 to reflect its release date and the start of the 30-60-90 recommendations within the Blueprint.

Thanks to Wenjing Chu from the Communications sub-committee and Alex Metcalf:

1. Good Health Pass (GHP) is one of our ToIP working groups, and they've just released **the 1.0 version of their proposed standard** for digital health passes, called the GHP Interoperability Blueprint.
2. Many ToIP members have invested time to make the GHP standard privacy-protecting and secure, so people feel **comfortable and confident** sharing their personal health information when required.

3. The Blueprint is another market step towards our goal of enabling **digital trust infrastructure that just works everywhere**, just like the Internet and the Web work everywhere.
