30 mins	Task Force reports	TF Leads	<ul style="list-style-type: none"> <li>• <b>Trust Assurance TF — Scott Perry</b> <ul style="list-style-type: none"> <li>◦ <a href="#">Comment period for Trust Criteria Matrix</a> and <a href="#">Trust Criteria Matrix Companion Guide</a> has completed. Need approval vote with GSWG.</li> <li>◦ Scott reported that there has not been much additional feedback.</li> <li>◦ <a href="#">Karen Hand</a> did provide an editing review of the Companion Guide.</li> <li>◦ Scott did a quick run-through of the Trust Criteria Matrix and the Companion Guide.</li> <li>◦ We discussed the relationship of different documents that we want to advance. From a sequence standpoint, the highest priority is the ToIP Governance Metamodel &amp; Companion Guide.</li> <li>◦ <a href="#">Judith Fleenor</a> is going to connect with Scott about putting them into the template.</li> <li>◦ <b>DECISION: Trust Criteria Matrix and Trust Criteria Matrix Companion Guide are approved as a Working Group Approved Deliverable.</b></li> <li>◦ Scott reported that he is suspending the weekly meetings of the Trust Assurance Task Force since it has completed all of its deliverables at this time.</li> <li>◦ <a href="#">Ricky Ng-Adam</a> has suggested to his government contacts that they should join ToIP.</li> <li>◦ Scott mentioned the good news about the Province of Ontario's <a href="#">publishing their digital identity strategy</a> that explicitly includes ToIP</li> <li>◦ <a href="#">Steve Magennis</a> asked if ISO 23220 Part 5 was on Scott's radar? The standard deals with mobile driver's licenses. Part 5 deals with trust confidence levels. Steve offered to make a connection there if it would help. <ul style="list-style-type: none"> <li>▪ If we want to do something larger, we can make a formal connection, but we can start more informally.</li> <li>▪ <a href="#">Daniel Bachenheimer</a> brought up ISO SC 17 WG 3, which is focused on security for travel documents. It has been discussed about pursuing an ISO WG on healthcare.</li> <li>▪ Scott brought up other ISO WG 17 SCs - see screenshot #1</li> <li>▪ Even though these ISO standards take a long time, we want to be involved.</li> <li>▪ Dan said he is the SC 37 liaison officer to ISO TC 307 on blockchain, so he can help there too.</li> </ul> </li> </ul> </li> <li>• <b>Governance Architecture TF — Drummond Reed</b> <ul style="list-style-type: none"> <li>◦ The main progress in the past two weeks has been on planning for terminology development to support the terms defined in the <a href="#">ToIP Governance Architecture Specification</a> and <a href="#">ToIP Governance Metamodel Specification</a> (see topic below).</li> <li>◦ Scott shared an update for <a href="#">Savita Farooqui</a> on the Governance Framework Matrix and Governance Framework Matrix Companion Guide. <ul style="list-style-type: none"> <li>▪ More was added to the Companion Guide explaining the matrix and how to use it.</li> <li>▪ A section called "objects of governance" was added.</li> <li>▪ It also has more guidance about how to operate a governing authority—more of a step-by-step process.</li> <li>▪ Scott believes it will be ready by the next plenary meeting.</li> <li>▪ ACTION: <a href="#">Scott Perry</a> will notify <a href="#">Savita Farooqui</a> about the requirement to provide 7 day advanced notice (via the GSWG mailing list) if she would like to request WG approval of new versions of the <a href="#">ToIP Governance Framework Matrix</a> and <a href="#">Governance Framework Matrix Companion Guide</a> at the next meeting.</li> </ul> </li> </ul> </li> <li>• <b>ToIP Stack Design Principles TF — Drummond Reed</b> <ul style="list-style-type: none"> <li>◦ See <a href="#">Design Principles for the ToIP Stack</a> (Google doc draft).</li> <li>◦ Good progress — document is approx. half way done — goal is to finish as quickly as possible.</li> <li>◦ Strongly encourage input/feedback of GSWG members.</li> </ul> </li> </ul>
10 mins	Terminology and Mental Models	<a href="#">Drummond Reed</a>	<ul style="list-style-type: none"> <li>• The <a href="#">Concepts and Terminology Working Group</a> is rolling out a capability for ToIP WGs to create their own <a href="#">terms wikis</a>.</li> <li>• We need to start this process to have defined terms and glossaries for our deliverables.</li> <li>• However, it is <b>strongly recommended</b> that we dig deeper to determine if we want to base these terms in sound <b>mental models</b></li> <li>• <a href="#">Rieks Joosten</a> has been leading a team building these mental models at eSSIF-Lab — see the <a href="#">Overview of eSSIF-Lab Mental Models</a></li> <li>• Do we want to begin this work, and if so, should we start a <b>GSWG Terminology &amp; Mental Models Task Force</b>?</li> <li>• <a href="#">Carly Huitema</a> asked how a mental model differed from an ontology? <ul style="list-style-type: none"> <li>◦ Drummond posited that a mental model is in fact a very simply ontology designed for one specific scope.</li> </ul> </li> <li>• We ran out of time to discuss further on this call.</li> <li>• ACTION: <a href="#">Drummond Reed</a> to start an async discussion on the topic of GSWG terminology, glossaries, and mental models on the #governance-stack-wg Slack channel.</li> </ul>
