To quote Carly:</p> <p>"Is anyone in Governance interested in working with me to organize the governance metamodel documentation to be pulled together in a learning module?"</p> <ul style="list-style-type: none"> <li>• Carly has started <a href="#">a draft of a Learning Pathway</a> for our governance deliverables.</li> <li>• This can make it much easier for newcomers to learn about a particular ToIP subject.</li> <li>• <a href="#">Drummond Reed</a> was super excited about establishing these for different ToIP subjects.</li> <li>• Carly said they should not be that hard to write. They also can help identify gaps that need to be filled.</li> <li>• Scott shared that having Learning Pathways will be very helpful for his new firm (below). <ul style="list-style-type: none"> <li>◦ Carly asked Scott to help identify what learning pathway(s) would be needed.</li> <li>◦ She also made the point that different Learning Pathways can be assembled into larger chunks.</li> <li>◦ Scott agreed that we can build a "tree" of these over time.</li> </ul> </li> <li>• Carly wants to keep the initial investment low for the authors and the value high for learners. <ul style="list-style-type: none"> <li>◦ It could be similar to the draft blog post (above).</li> <li>◦ It could also be delivered in multiple formats, i.e., a document, a slide deck, a video.</li> </ul> </li> <li>• Savita also envisioned that it could be an interactive document/workflow that outputs a governance framework document.</li> <li>• ACTION: CHAIRS to put the Learning Pathway Outline Drafting as our first agenda item for the next meeting.</li> </ul>

10 mins	Goals and resource requirements for GSWG in 2022	All	<p>Early on in the GSWG, we agreed that our first primary milestone was to get out our baseline GSWG specifications (the 3 deliverables above). We've also published 8 additional governance, trust assurance, and risk assessment tools.</p> <p>We anticipated that once we had our baseline, the next step would be to produce <b>layer-specific governance framework templates</b> to publish as ToIP Recommendations. Questions we should discuss:</p> <ol style="list-style-type: none"> <li>1. Is this still our next priority?</li> <li>2. If so, which layer-specific template should come first?</li> <li>3. Do we have the volunteer resources within the GSWG to do this work in, say, the first half of 2021?</li> </ol>
