Neil Thomson proposed mapping Trust Checkpoints or Trust Queries(see here: https://github.com/trustoverip/tswg-trust-registry-tf/discussions/68#discussioncomment-4926563) for further understanding where and from whom Trust inputs are gathered. <p>Eric Drury created a spreadsheet we can use to start mapping the trust queries.
